## Table Games Hot Seats

"Official Rules"

1. **TO ENTER:** Must be a Players Club member to participate. Must be playing with their Players Club card at the time of the hot seat. By participating in the promotion, the Guest agrees to be bound by the official rules of the promotion. This promotion is open only to individuals who, at the time, (i) possess valid photo identification, (ii) are a Players Club Member, and (iii) age 21 or older. Employees of The Tachi Palace Hotel & Casino, affiliates, sales representatives and advertising and promotion agencies are not eligible to participate in this promotion.

3. **Prizes:** Ten (10) winners will win their share of \$5,000 in cash. Each winner will receive \$500 in Cash.
